



## 2024–2025 ASTRO Education Committee Disclosure of Relationships

The American Society for Radiation Oncology (ASTRO) is an Accreditation Council for Continuing Medical Education (ACCME)-accredited CME provider and complies with the ACCME Standards for Commercial Support. In accordance with these Standards, the ASTRO Conflict of Interest Policy and the Council for Medical Specialty Societies' Code for Interactions with Companies, ASTRO is disclosing here the relationships between the members of the 2024–2025 ASTRO Education Committee and other entities related to oncology or radiation therapy.

If a Committee member declines an honorarium and it is paid directly to charity, the honorarium is not included. Honoraria from accredited CME providers are not included.

**Ownerships, Investments, Intellectual Property** = includes stock, stock options, partnership, royalties or patents. Stocks in mutual funds, blind trusts or other holdings that are not controlled by the individual or an immediate family member are not included.
